General Terms and Conditions

1. Prices and Included Costs

The prices specified in the quotation are net prices excluding VAT, and include the following

- In case of imported equipment the occurrent fees of customs, customs examination, packaging and environmental product fees
- Shipment and professional installation throughout Hungary
- Cost of installation and auxiliary materials necessary for equipment installation insofar as the standardized utility hook-ups have been prepared within 1 meter of the installation point pursuant to the related standards and/or manufacturer's specifications (the professional preparation of the utility hook-ups shall be provided by the Contracting Party at all times)
- 12-month free and comprehensive warranty which can be prolonged to 24 months by signing a maintenance contract and having the compulsory maintenance works performed and certified (24-month extended warranty)
- User manual in Hungarian in paper boards and/or in electronic form
- One-occasion training on proper use of equipment
- Free storage for 10 days in case the Contracting Party is not able to receive the goods ordered or requires storage for any reason
- 10 years of comprehensive parts supply following delivery (in case of Meiko, MKN and Retigo products we guarantee parts supply for 20 years following the end of production of the given type of equipment) pursuant to the relevant legal regulations
- Commencement of repairing equipment failure within 48-72 hours following failure report
- The on-site installation of the commercial kitchen exhaust hood will be priced separately

2. Delivery Deadlines

8-12 weeks following the receipt of the written order and advance payment, according to manufacturer's confirmation within 3-5 work days in case of items on stock In the case of custom or made-to-measure products, the lead time is 6-8 weeks from the on-site measurement and the written approval of the manufacturing drawing

3. Validity of Quotation

30 days following dispatch insofar as not indicated otherwise in price quotation.

4. Exchange rate guarantee and terms of payment

Prices Quoted in HUF (payment in EUR):

Prices are guaranteed up to an exchange rate of 370 HUF / EUR based on the K&H Bank's foreign currency selling rate. If, at the time of performance, this rate exceeds 405 HUF / EUR, A.MeCoD Zrt. is entitled to proportionally adjust the prices in the final invoice.

Prices Quoted in EUR (payment in HUF):

Invoicing and payment shall be made at the K&H Bank's foreign currency selling rate valid on the date of performance.

Payment Schedule:

- 50% advance payment upon order confirmation
- 30% upon distributor's declaration of readiness (that the goods are ready for delivery)
- 20% within 8 days after completion of performance

5. Invoicing

The Contracting Party accepts that A.MeCoD Zrt. is entitled to send an invoice in electronic form which it is obliged to receive

6. Legal Framework

The proper law of contract to be applied in any matters not regulated by the terms and conditions of the present contract shall be the regulations of the Civil Code (Act V. of 2013) as well as the Government Decree no. 151/2003 (IX.22.)
